EITZEN UTILITY RATE SCHEDULE

Electricity available for single - phase residential and commercial service, three phase commercial service and dual fuel service. Dual fuel rates only for separately metered controlled space heating loads where a fully automated backup heating system is available.

Energy Rates

Residential service charge:	\$8.20 per month
Three phase service charge:	\$18.45 per month
Energy charge:	\$.1132 per KWH \$.1344 per KWH June, July & August

Dual Fuel Service

Charge for additional meter:	\$1.00 per month
Energy charge	October-May \$.04994 per KWH June-September \$.1094 per KWH

Note: The above rates will increase or decrease according to any wholesale rate changes from Mi Energy Co-op.

Water Rates

Non-Metered:	\$21.50 per month
Metered:	\$12.80 per month first 1,000 gallons (flat charge) plus .0055 per gallon over 1,000 gallons.
Bulk Water:	\$10.25 per 1000 gallons
Sewer Rates	\$13.35 per month plus .0026 per gallon of water used after 1000 gallons.
Non-Metered:	\$17.50 per month

UTILITY POLICIES

Electrical

- A. \$200.00 Hook-up Charge
- B. Meter will be furnished
- C. Electrical line will be furnished to the property line
- D. Hook-up to the buildings will be the property owners expense
- E. Temporary hook-up is property owners expense
- F. Billing begins at the time service is energized
- G. There is a \$50.00 disconnect charge if bill is delinquent
- H. There is a \$15.00 fee applied to account if meter card is not returned by the 1st of each month.
Meter cards can be dropped off or mailed to the City Hall

Water

- A. \$400.00 Hook-up Charge
- B. Meter will be furnished
- C. Curb stop and valve will be furnished
- D. Hook-up to the water main, installation of curb stop on edge of property line and street repair including packing of back fill in the street will be property owners expense.
- E. If remote reading meter is required the difference in price is charged to the property owner
- F. If meter is leaking or stopped the City will change at their cost
- G. If meter is leaking, broke or froze due to neglect, then owner will be charged
- H. In house leaks that are owner neglect will be charged meter reading
- I. Leaks beyond curb stop are property owners expense if not repaired
- J. The City has the right to repair any neglected leaks and will bill the property owner

Sewer

- A. \$850.00 Hook-up Charge
- B. \$2000.00 Additional charge if property has not been previously assessed
